

Triple Play Contest Rules

Paperwork information and trip package information can be picked up during regular business hours (excluding holidays). All trip information and cash must be picked up in person. Trip and cash information will not be mailed. All trips given away have no redeemable cash value and is non-transferable.

Country Cash Song of the Day (9/9/19 – 9/27/19) Listen each weekday (Monday – Friday) morning to Shamus & Annie for the day's Country Cash Song of the Day. Then, listen for the song to play anytime on that day between 7am – 6pm. Caller #5 at 765-448-6525 will win \$105.

Triple Play Flyaway (10/7/19 – 10/25/19) Listen each Monday – Thursday between 6am – 6pm for the Triple Play Flyaway sounder. Caller #5 at 765-448-6525 will be qualified to pick from one of three trips (See Item #4 for list of trips). On Friday of that week, one qualifier will be randomly drawn to select one of the remaining trips.

\$1,000 Thursdays (11/1/19 – 11/21/19) Listen each Friday, Monday, Tuesday, and Wednesday for the \$1,000 Thursdays Cue-to-Call. The first five people to call in at 765-448-6525 will be qualified to win that Thursday's \$1,000. The cue-to-call will play 5 times each Friday, Monday, Tuesday, and Wednesday. On Thursday, Shamus & Annie will randomly draw one winner of \$1,000 from that week's qualifiers.

1. **No purchase necessary.** Void where prohibited by law. All federal, state, and local law regulations apply.
